

ADMISSION FEE EXEMPTIONS: ELIGIBLE CANDIDATES AND SUPPORTING DOCUMENTS

1. Children of active or retired teaching, auxiliary teaching, and non-teaching staff from educational institutions.

Fee subject to exemption: Registration fee. The processing fee of 200 RON must still be paid.

Supporting documents: Official certificate (adeverință) confirming the status of teaching, auxiliary teaching, or non-teaching staff.

2. Active or retired teaching, auxiliary teaching, and non-teaching staff of UBB.

Fee subject to exemption: Registration fee. The processing fee of 200 RON must still be paid.

Supporting documents: Official certificate (adeverință) confirming the status of teaching, auxiliary teaching, or non-teaching staff.

3. Orphans of one or both parents, up to 26 years of age.

Fee subject to exemption: Admission fee = registration fee + processing fee (fully exempt).

Supporting documents: Death certificate(s).

4. Children from single-parent families, up to 26 years of age, in accordance with the situations presented in points 4.1. – 4.6.

Fee subject to exemption: Admission fee = registration fee + processing fee (fully exempt).

4.1. Unmarried person

Supporting documents: Statutory declaration (declaration on own responsibility) from the parent regarding their marital status, confirming that they are unmarried.

4.2. Divorced person, if the other parent does not contribute to the child's maintenance

Supporting documents: Court decree pronouncing the divorce or a divorce certificate issued by a public notary upon dissolution of the marriage.

4.3. Person whose spouse is declared missing by a court ruling

Supporting documents: Court ruling declaring the spouse missing or a social assessment report (anchetă socială).

4.4. Person whose spouse is in one of the situations provided for in Art. 178, letters c) or d) of Law no. 287/2009 on the Civil Code, republished, with subsequent amendments and additions

Supporting documents: Court ruling establishing a curatorship (hotărâre judecătorească de instituire a curatelei).

4.5. Person whose spouse is in pre-trial detention for a period exceeding 30 days or is serving a prison sentence and does not contribute to the child's maintenance

Supporting documents: Court decision maintaining the parent's detention status or certificate issued by the detention facility.

4.6. Person appointed as a guardian or who has been entrusted with or placed in foster care one or more children and is in one of the situations provided for in points 4.1. – 4.5.

Supporting documents: Court ruling establishing the guardianship (hotărâre judecătorească prin care a fost instituită tutela).

5. Children coming from foster care centers, up to 26 years of age

Fee subject to exemption: Admission fee = registration fee + processing fee (fully exempt).

Supporting documents: Court ruling establishing the special protection measure or an official certificate issued by the DGASPC (General Directorate for Social Assistance and Child Protection).

6. Persons at risk of losing their capacity to meet their daily living needs due to illness, disability, or poverty

Fee subject to exemption: Admission fee = registration fee + processing fee (fully exempt).

Supporting documents (as applicable): Certificate of permanent severe or accentuated disability OR an income certificate proving that the average monthly net income per family member over the last 12 months is lower than the national minimum net wage (2,574 RON).
